## Interim Consent Letter

**Sub: Recognition to Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar and fresh approval to its Narayan School of Law, Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar for imparting three year LL.B., five year BA LL.B. and five year B. B. A. LL.B integrated courses with intake of two sections of 60 students in each section in each course for a period of two years i.e. for the academic years 2018-2019 and 2019-2020.**

Sir,

The Standing Committee of the Bar Council of India at its meeting held on 21<sup>st</sup>, 22<sup>nd</sup> and 23<sup>rd</sup> September, 2018 considered the inspection report of Narayan School of Law, Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar submitted by the inspection team of the Bar Council of India.

After consideration, as per Section 7 (1) (i) of the Advocates Act, 1961 Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar be granted **recognition for the purpose of conferring the degrees of law for imparting three year LL.B., five year BA LL.B. and five year BBA. LL.B integrated courses from the academic year 2018-2019 and further fresh approval to its Narayan School of Law, Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar for imparting three year LL.B., five year BA LL.B. and five year B. B. A. LL.B integrated courses with intake of two sections of 60 students in each section in each course for a period of two years i.e. for the academic years 2018-2019 and 2019-2020.**

Since, now almost end of September for starting session 2018-2019, approval is granted only if the college holds extra classes as per requirement of the Rules per day, per week and per month for the said class, which is following short to be covered by, with mandatory in this regard.

**Reply may be sent with undertaking by the college for these extra classes within six weeks for final consideration.**

**Specific conditions imposed by the inspection team and approved by the Committee :-**

1. School of Law/University to augment its' library with Wi Fi connection with free access to the faculty and students. Computers also to be kept in the library/Computer Laboratory so that on an average, ten (10) students have one (1) computer.
