Sub.: Consideration of letter No. GNSU/RO/21/90 dated 7.2.2022 and letter No. GNSU/RO./22/231 dated 14.3.2022 and grant of one additional section each alongwith existing section i.e. total two sections in each course in three year LLB course, five year BA LLB course and five year BBA LLB course for the academic session 2022-23.

Sir,

This is to bring to your kind knowledge that the Standing Committee of Legal Education Committee of Bar Council of India by virtue of its meeting held on 10th and 11th April, 2022 considered the matter of Narayan School of Law, Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar .

Narayan School of Law, Gopal Narayan Singh University, Jamuhar, Sasaram, Rohtas, Bihar was established in the year 2018 and was accorded approval of affiliation to start two sections each of 3-year LLB. Course, 5-year BA LLB and 5-year BBA LLB course with intake of 60 students in each section. When the matter came up for extension of approval of affiliation, the inspection team noticed that there was a shortage of classrooms as well as teachers. Taking into account, the shortfall of admissions and shortage of faculties, extension of approval of affiliation was restricted to one section in each course for 2021-22 onwards. The matter was taken up before the Hon'ble Patna High Court and decision taken by the BCI though upheld.


The CLE submitted a letter stating that they had appointed 39 permanent core faculty, as required and complied with other conditions but mistakenly it was reported as 37 permanent core faculty and made a request for restoring of the sections.


The record discloses that there was compliance on the part of CLE. Hence, the previous strength in each of the courses is restored and approval of affiliation

is accorded to one additional section each along with existing one Section each i.e. total two sections each in three year LLB course, five year BA LLB course and five year BBA LLB course for the academic session 2022-23.
