Enquiry Report

A meeting of the Disciplinary Committee of NSL was convened today on 20.01.2021 at 2 P.M. to consider the information in writing submitted by the Guard, Mr. Jyotindra Kumar.

The members considered and discussed the contents of the application of the Guard on duty, Mr. Jyotindra Kumar and summoned the students practicing for the cultural programme on the terrace of the institute and the student who went up stairs with intention to disturb the students preparing for the cultural programme.

The college student indicated in the information letter of the Guard was located & his name was Subham Kumar Singh a student of B.A.LL.B., 1st Semester bearing Roll No. 20BLB025 who went up stairs alongwith others to disturb the students preparing for cultural programme as alleged.

Mr. Subham Kumar Singh apologised in his application for his objectionable behaviour with the students preparing for the cultural programme and the students preparing for the cultural programme were also of the view to excuse Mr. Shubham Kumar Singh for his alleged behaviour on the days i.e. 18.01.2021 and 19.01.2021.

But the fact that he had called students of other department particularly the students of FMS with intention to disturb the on going preparations of cultural programme was still a matter of consideration before the Disciplinary Committee.

In the mean time, an application of the students of 1st Semester complaining the ragging by the seniors also came to the light of the members of Anti-Ragging Committee and Internal Complaint Committee on 21.01.2021 and some faculty members of both the committee were common in both the committee and it was realised that the issue was inter-related to each other, both the committee conducted a joint meeting 21.01.2021 at 4 PM.

During our enquiry following fact were detected:-

- The complainant had written the application on behalf of all the students and most of them had denied the substance of the complaint.
- 2. Complaint regarding the ragging was denied by all the students.
- 3. Some students even alleged that they had signed the blank paper, as they were told to sign it for the identity card.
- 4. The complainant did the fake signature of some of the students and also threatened them.

The Committee during the enquiry observed as follows:-

- 1. Mr. Subham Kr. Singh alleged in writing and took signature of some the students and had made false allegation of ragging.
- 2. He tried to persuade the matter of ragging intentionally and hindered the peace of the institution.
- 3. He threatened and tried to influence the other students for wrong cause.

On the basis of the submissions of the Ist Semester students before the committee, the committee found a prima-facie involvement of Mr. Shubham Kumar Singh of B.A.LL.B. (1st Semester) bearing Class Roll No. 20BLB025 into the incidence of forcing his classmates to sign fake allegation letter to protect himself from the incidence he committed on 18.01.2021 and 19.01.2021 with the students preparing for the cultural programme on the terrace of the NSL.

The names of the students of the FMS involved into the incidence were also revealed by the Security Chief of the University Mr. Arshad Warsi and the same is also attached herewith for perusal.

Therefore, considering the paramount interest of the institution i.e. maintaining healthy atmosphere in the institute, appropriate disciplinary action against Mr. Shubham Kumar Singh B.A.LL.B. 1st Semester for the time being i.e. suspension from class for atleast 10 days is recommended unanimously & matter may be referred to the Proctorial Board of the University for their perusal and further appropriate action.

1. BACKGROUND

The Chairman of the Anti Ragging Squad (hereinafter ARS/ARC) received a complaint from the UGC Anti Ragging helpline (Complain ref No. BR_0140) on 22nd September 2023 at 08:47 PM relating to alleged incidence of ragging by a Student who pursuing BPT first year from the college. She was tortured on 21st September 2023, at around 10 PM by her two roommates and 1 girl with the help of 10-15 seniors in hostel after which she get fainted and was carried to hospital in emergency. I have informed about the same in the local police station. The hostel in-charge and college since not cooperative regarding the same. I am her brother on her behalf. When I talked to her at around 4 am in the morning she was fearful and not.

The Grievance of the complaint are related to the torture by roommates in the hostel.

On the same date the Chairman of ARS requested to the Girls Hostel members to identify the victim & respectively members identify the Victim and consoled and assured for her safety and security in and around GNSU. Moreover, she was assured that a proper inquiry of the alleged incident of ragging would be delt under UGC regulation for curbing the menace of Ragging in the Higher Education Institution.

- 2.1 The committee Chairman Prof. (Dr.) Arun Kumar, Professor, Dept. of Biochemistry, NMCH on leave in view of the family issue and could not attend this meeting and authorized Dr. Sourabh Singha Roy, Associate Professor, FMS to precede the meeting.
- 2.2 All the decisions taken during the meeting was informed to Committee Chairman through telephonic conversation.
- 2.3 The committee member Dr. Nitesh Kumar Singh, Assistant Professor, Faculty of Agriculture, could not attend this meeting but he was informed through telephonic conversation.
- 2.4 This is reference to above mentioned complaint lodged by Ms. Arti Kumari and received via email on 22nd September 2023 at 20:47 (copy attached) on UGC Anti-Ragging portal.

3. FINDINGS

Her brother also informed about the incidence to local police station. He also alleged that the hostel in charge and college were not cooperating regarding the incidence. He talk to her sister at around 4 am and she was fear full.

After receiving the above complain the Chairman of the Anti Ragging Committee, Gopal Narayan Singh University requested the superintendent girls hostel to identify the victim and come along with the victim to the office the Anti Ragging Committee. After Investigation it has come to the notice of the Anti-Ragging Committee that the matter was started with a photograph taken by the victim BPT 1st Semester student. She has clicked photograph of the roommates encoding one another girl in inappropriate manner in private space without any prior consent. This has laid to a hot discussion amongst the 1st semester students all classmates and her roommates. 4 MBA 1st semester students tried their best to pacify the situation but unfortunately Arti Kumari fainted due to her own health issue.

The Committee counselled the victim and after full satisfaction by the counselling of the committee the matter was solved to the satisfaction of Ms. Aarti Kumari which she has submitted before the Committee in the writing also and marked as annexure-I. to this report.

Conclusion

On the basis of submissions made by Ms. Aarti Kumari and enquiry done by the Anti-Ragging Committee it was found that the basis of the incidence was found personal in nature and arise because of health condition of the victim and not a matter of ragging. She was satisfied with the action taken by the Anti Ragging Committee. Accordingly the matter was disposed off.



The Chairman of the Anti Ragging Squad (hereinafter ARS/ARC) received a complaint from the UGC Anti Ragging helpline (Complain ref No. BR_0139) on 22nd September 2023 at 02:20 PM relating to alleged incidence of ragging by a Student who is pursuing BMS first year from the college. He was tortured on 21st September 2023, at around 06:00 PM by some students. According to him when he was drinking tea at the tea stall outside the university campus, Some students came there and asked him two or three times who the students of BMS 1st semester were and the victim told him that he was a student of BMS . After that they abused and beat him badly for unwanted reasons.

On the next day the Chairman of ARS requested to the ARS committee members to identify the victim & respectively members identified the Victim and consoled and assured for his safety and security in and around GNSU. Moreover, he was assured that a proper inquiry of the alleged incident of ragging would be delt under UGC regulation for curbing the menace of Ragging in the Higher Education Institution.

The Chairman of the ARS also directed to the Hostel member for proper care of the Victim.

2. SUMMARY OF DEPOSITION

2.1 The committee Chairman Prof. (Dr.) Arun Kumar, Professor, Dept. of Biochemistry, NMCH was on leave in view of the family issue and

MBA student of the university.

After receiving the above complain the Chairman of the Anti-Ragging Committee, Gopal Narayan Singh University called up a committee meeting. The committee has come up with the following observations:

- 1. The student mentioned in the case reference, Ms. Chhaya Kumari (23MBA006) has already lodged several complaints before in writing to the Dean, Faculty of Management Studies regarding the objectionable behavior of the complainant, copies of which are in departmental records.
- 2. On 16th of May, 2024 afternoon Ms. Chhaya Kumari met the Dean, FMS and Complained against the complainant regarding his repetitive misbehavior
- 3. Several warnings followed by the fifteen days suspension (on 16.05.2024) have already been done by the department against the complainant after several rounds of enquiry done by departmental disciplinary committee.
- 4. It is a false allegation that the complainant issues are not being considered because the complainant too has submitted in the writing that there has been a personal relationship with Ms. Chhaya earlier

Conclusion

On the basis of enquiry done by the Anti-Ragging Committee it was found that the basis of the incidence was found personal in nature. It is not a case of ragging at all.

The complainant has been abusing and harassing Chhaya Kumari, (a student of MBA 1st year) and her Family directly or indirectly since January 2024. The complaint received, against the complainant which was duly forwarded to the Internal Complaint Committee (ICC) at Gopal Narayan Singh University on January 25, 2024. Subsequently, the complainant also filed a case against Chhaya, which was referred to the ICC on January 27, 2024. Both parties were given the opportunity to present their cases, and appropriate actions were taken by the ICC based on their findings. On this very matter the parents of Chhaya Kumari were so worried about their daughter's career. Looking into the seriousness of the issue the parents of the complainant were also called separately.

Furthermore, on April 25, 2024, another complaint was lodged against the complainant by Mukta, a 1st-year MBA student, for harassing her by calling her as late as 03:00 am. Consequently, the accused party was suspended and was instructed to appear with his parents. Additionally, the complainant was warned regarding his behaviour towards girls.

Most recently, on May 16, 2024, Chhaya Kumari filed a complaint against the sacous elopasty from a rassing her within the campus premises. In response to this complaint, the complainant has been suspended for
