Grievance received by Mr. Anish Kumar Anand, S/O Anand Kumar Anand, Narayan Institute of Pharmacy, Gopal Narayan Singh University, Jamuhar, Sasaram, Bihar.

The following points are related with said ticket

- 1. Anish Kumar Anand Registered in July 2019 for the B.Pharm. course at Narayan Institute of Pharmacy, Gopal Narayan Singh University, Jamuhar.
- 2. <u>His attendance is less than 30 percent</u>. As per University law the attendance should be more than minimum 75 percent. Based on attendance he is not eligible to sit and write the examinations.
- 3. He has deposited only Rs. 56,000 for B. Pharm course at the time of admission.
- 4. The total fee of B. Pharm course was Rs. 3,63,000.
- 5. The GNSU is not directly related with the DRCC (Bihar Student Credit Card). University is self financed and University only facilitates the students for the DRCC.
- He has applied in DRCC for loan but due to some technical issues, amount was not credited in the University account, but the University authority has allowed him in every semester to sit and write the examinations.
- 7. <u>Till date the total due amount is Rs. 3,07,000</u>, and he is in final year, So the University is not allowing to appear in the final year University Examination.





Mr. Subham Kumar Singh apologised in his application for his objectionable behaviour with the students preparing for the cultural programme and the students preparing for the cultural programme were also of the view to excuse Mr. Shubham Kumar Singh for his alleged behaviour on the days i.e. 18.01.2021 and 19.01.2021.

But the fact that he had called students of other department particularly the students of FMS with intention to disturb the on going preparations of cultural programme was still a matter of consideration before the Disciplinary Committee.

In the mean time, an application of the students of 1st Semester complaining the ragging by the seniors also came to the light of the members of Anti-Ragging Committee and Internal Complaint Committee on 21.01.2021 and some faculty members of both the committee were common in both the committee and it was realised that the issue was inter-related to each other, both the committee conducted a joint meeting 21.01.2021 at 4 PM.

- The complainant had written the application on behalf of all the 1. students and most of them had denied the substance of the complaint.
- Complaint regarding the ragging was denied by all the students. 2.
- Some students even alleged that they had signed the blank paper, as 3. they were told to sign it for the identity card.
- The complainant did the fake signature of some of the students and 4. also threatened them.

The Committee during the enquiry observed as follows:-

- Mr. Subham Kr. Singh alleged in writing and took signature of some the students and had made false allegation of ragging.
- He tried to persuade the matter of ragging intentionally and 2. hindered the peace of the institution.
- He threatened and tried to influence the other students for wrong 3.

On the basis of the submissions of the 1st Semester students before the committee, the committee found a prima-facie involvement of Mr. Shubham Kumar Singh of B.A.LL.B. (1st Semester) bearing Class Roll No. 20BLB025 into the incidence of forcing his classmates to sign fake allegation letter to protect himself from the incidence he committed on 18.01.2021 and 19.01.2021 with the students preparing for the cultural programme on the terrace of the NSL.

The names of the students of the FMS involved into the incidence were also revealed by the Security Chief of the University Mr. Arshad Warsi and the same is also attached herewith for perusal.

Therefore, considering the paramount interest of the institution i.e. maintaining healthy atmosphere in the institute, appropriate disciplinary action against Mr. Shubham Kumar Singh B.A.LL.B. 1st Semester for the time being i.e. suspension from class for atleast 10 days is recommended unanimously & matter may be referred to the Proctorial Board of the University for their perusal and further appropriate action.
