



Based upon the written statements of both the parties the same has been forwarded for necessary action.

On 1st February, 2024 both the persons were called separately by the chairman of the committee and committee members namely Dr. Kumari Jyoti, Assistant Professor, Narayan Institute of agricultural sciences and Dr. Kheyali Roy, Assistant Professor, Faculty of management studies and the matter was discussed in person.

After analyzing the written statements, discussion and interaction with both the students we concluded that both the students were equally responsible for the situation that occurred. Both had previous relationship which they both accepted and it was also known by the parents of both the students in between they had some issues related to sharing of pictures with the family members and this matter is not at all related to any kind of harassment neither all this happened in the university premises.

The enquiry committee had found both of them guilty as they both accepted their previous mistakes. Further both of them had given written confession that they will not indulge in these type of activities in future and if found necessary action can be taken.

The matter resolved after face to face discussion. No further inquiry was demanded by both the parties related to the above cited matter and both of them were satisfied with the Decision.

Being the chairman of the committee, the student were assured that they will not communicate with each other to prevent misunderstandings in future.

Dear Madam/Sir,

We have received a complaint of ragging from a student of Narayan Paramedical Institute & Allied Sciences. You are requested to identify & counsel the victim so that he/she feels safe and knows that authorities are with him/her & action will be taken on his/her complaint. You are also requested not to disclose the identity of the victim. The details are given below

"7.1 Action to be taken by the Head of the institution by the order of Hon.

Supreme Court:

on receipt of any information concerningany reported incident of ragging, the Head of the institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a First Information Report (FIR), within twenty-four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

v. Violation of decency and morals through ragging;

vi. Injury to body, causing hurt or grievous hurt;

x. Assault as well as sexual offences or unnatural offences;

xi. Extortion;

xvii. Physical or psychological humiliation;





The members of the Committee asked him twice and thrice that he should not be fearful for anything and should submit his versions boldly and truly before the Committee but finally he denied and submitted in his written submission the name of Mr Shashi Yadav was given by him under miss understanding of someone else but there after he named other four Persons/Students and same were as follows.







MBA student of the university.

After receiving the above complain the Chairman of the Anti-Ragging Committee, Gopal Narayan Singh University called up a committee meeting. The committee has come up with the following observations:

- 1. The student mentioned in the case reference, Ms. Chhaya Kumari (23MBA006) has already lodged several complaints before in writing to the Dean, Faculty of Management Studies regarding the objectionable behavior of the complainant, copies of which are in departmental records.

Prelude:-

Over the matter reported to the Dean, FMS, Disciplinary Committee of FMS has received an enquiry letter regarding the nuisance created by Rakesh Kumar, 23MBA067, students of MBA 2nd Semester, in the morning of 6th April for which the Committee has initiated the preliminary investigation for following reasons:

 Creating nuisance at GNSU's Hospital Gate Inappropriate behaviour of Mr. Rakesh Kumar

The statement of the Managal Devi) and telephonic statement from his form. Shiv Mangal Devi) and telephonic statement from his father, Mr. Vishwanath Singh regarding the incidence.

After having all statements, Committee members have observed that, Rakesh Kumar is currently undergoing treatment with a Neuro Psychiatrist, Patna for the last two years and he has advised to take his medicines regularly. Not only this, committee got to know that earlier he was a severe drug addict and has undergone his treatment with deaddiction centre, Patna twice (three months each centre) in year 2021 & 2022 to overcome his addiction for marijuana substance (Prescriptions Diagnostic Reports Attached). During the interrogation, Rakesh Kumamhas clearly accepted his consumption of drug on the date of incidence. He has clearly accepted that he has received "weed" from one

of his friend Mr. Rishabh, a student of Pharmacy and consumed the drug at room no. 1, fourth floor, Law Building. However, Mr. Rakesh Kumar has denied his inappropriate behaviour in-front of NMCH hospital perhaps due to his unconsciousness at the said moment of time (*Statement Attached*).

In the same connection, when Disciplinary Committee members tried to interrogate the matter with his parents, they have responded conscientiously. They told the committee about their poor economic condition, dispute in their family that leads to unstable mental health of their son, Rakesh Kumar. His father and mother both were worried and shown their seriousness about their son's health as well as his education. As a result, the Disciplinary Committee members have decided to call off action against Rakesh Kumar due to his illness.

Observation of the Disciplinary Committee:-

On the basis of above mentioned facts, the committee has come to conclusion that Rakesh Kumar, 23MBA067, is not doing good with his mental health and his family economic condition is also not so good. Thus, he needs serious psychiatric counselling at the earliest. Thus in the same connection, committee is requesting Dean, FMS, GNSU to request University Authorities for his counselling & also to revoke his suspension so that he may start attending his semester classes with minimal loss after giving a warning message to him.





Report of Disciplinary Committee NSL, GNSU

In view of the Letter no. GNSU/Ag/Hostel/23/156 dated 27.03.2023 which was referred to our Dean, Faculty of Law and the Dean, had forwarded to the Disciplinary Committee of the Faculty of Law. Accordingly a meeting of the Disciplinary Committee was convened on 28th March, 2023 and 12th of April, 2023 at 04:00 p.m. both of the days to enquire into the issue of locking the girls in the hostel room no. 317 and displaying of mobile number of the concerned girls on mess menu and paste it on the hostel walls. The following members were present in the meeting:

- 1. Dr. Narmada Singh
- 2. Dr. Sangeeta Kumari
- 3. Dr. Abhishek Singh (Hostel Superintendent Boys)
- 4. Mr. Subodh Kumar Singh
- 5. Ms. Pragya Singh (Hostel Superintendent Girls)

All the students individually were called upon in the meeting and all were heard separately, namely Satvika Swara of B.B.A.LL.B.-3rd Sem., Ishitva and Shaline Raje of LL.B.-3rd Sem., Mona Kumari LL.B.-5th Sem., Shreyashi and Simran Kumari of B.B.A.LL.B.-5th Sem. The written statements were taken of all the students which is annexed herewith marked as Annexure- to this report.

The committee with its full quorum discussed the whole issue and after hearing and perusal of written statements and after cross examination of the students following are facts in brief:

- 1. Students were divided into two groups in enmity which they had from long time and are alleging each other in their defense.
- 2. These two groups are namely one of Shreyashi, Satvika and Simran and 2nd of Mona, Ishitva and Shalini.
- 3. Satvika shared the room with the opponent group students namely Ishitva and Shalini and alleging them of conspiracy of locking the girls of the room no. 317.
- 4. Where as Ishitva and Shalini confessed that they had complained verbally about Satvika to a teacher of the faculty and annoyed thereby she is retaliating by plotting against Ishitva and Shalini.

Ishitva and Shalini were agitated by the behavior of Satvika and her friends, as they Dean started commenting them and disturbing them in their studies, which they revealed faculty of Law

6. Simran a student of B.B.A.LL.B.-5th Sem. When in interrogated in front of Dean, NSL had admitted the fact of falsely accusing that she has seen Ishitva and Shalini during the locking of room no. 317. Which was not true and she was taking side of her friend Shreyashi B.B.A.LL.B.-5th Semester, moreover in retaliation to Ishitva and Shalini and gave statement in writing against them.

After perusal of the facts mentioned above the committee members come to any definite conclusion as to who was actual culprit of locking the room no. 317 of the Hostel and reaching to any definite conclusion on the basis of doubt may be injurious to any particular student. This was also be due to non-availability of CCTV Camera's in the girls hostel.

Same conclusion may be inferred regarding allegation of displaying the mobile no. of a particular student on the mess menu chart and pasting it on the walls of Hostel. In absence any conclusive proof any attempt to decide the issue would be a lope sided decision in the opinion of the disciplinary committee of NSL.

As discussed above the Disciplinary Committee came to conclusion that both the incidents had happened and definitely both the incidence were a matter of indiscipline.

Considering the above facts & circumstances the Disciplinary Committee recommends as follows:

- 1. A General undertaking prepared by the committee to be signed by each of the students whose names were discussed above.
- 2. The undertaking given by the students must be countersigned by the parents of the student.
- 3. The parents should be called personally and the member of disciplinary committee will discuss the conducts of each students with their parents separately.
